
#### Rev. Dr. Eldridge Lucas, III - Moderator

#### Rev. Dr. Robert Elliott, Jr. - 1st Vice-Moderator

Rev. Dr. Robert Lincoln Elliott, Jr. is a native and currently resides in Claremont, located in Surry County, Virginia. Having four sisters, he is the only son born to the late Robert L. and Dolly Elliott, Sr. After attending and graduating from Surry County Public Schools, he attended Norfolk State University before joining the United States Air Force. For four years while in the Air Force, he worked diligently with the Military Police Unit. That was where God taught him tolerance for all people in all circumstances.

Returning to civilian life, he joined the Prince George County Police Department where he remained for thirteen years, ending his service as a detective and the unofficial chaplain for the department. Pastor Elliott knew soon after God had a higher calling for him.

As a child of God and an anointed "leader of the flock", Pastor Elliott took the helm at Morning Star Baptist Church in 2001 – the church where he was baptized, where he was ordained as a deacon in 1988, where he was licensed as a minister in 1991, and where his family still actively attends. Being born into a musically gifted family, he truly believes that we should "make a joyful noise unto the Lord" and will often begin or end his sermons with a soulful musical offering.

Pastor Elliott's growth at Morning Star Baptist Church with the late Rev. Dr. E. L. Pastor Elliott grew under the functioning of the Holy Spirit and God sent him to the Union Baptist Church in Spring Grove, Virginia to lead His people. Pastor Elliott continued his matriculation in the realms of Theology at the Richmond Virginia Seminary. In 1997, he received his Bachelor's degree from the Seminary. Under his guidance as the spiritual shepherd for his Morning Star Family, Pastor Elliott has led his flock to greater heights and a better understanding of the infinite wisdom, mercies and goodness of God through His Word. #### Rev. Dr. Bobby Lee Taylor -2nd Vice Moderator

The Reverend Dr. Bobby Lee Taylor was born in Evergreen, Alabama to Mr. and Mrs. Earnest Taylor and is the oldest of thirteen children. At the age of eleven, he accepted Christ as his Lord and Savior and was baptized at the Mount Zion Baptist Church in Owasa, Alabama. He was educated in the public school system of Evergreen, Alabama. He received his calling to the Gospel ministry and was licensed to preach on August 14, 1983 and ordained on December 20, 1984. He has over twenty five years of progressively responsible experience in church work and administrative leadership. He has preached in several states and accumulated many awards and achievements in his Christian journey and has several years of voluntary chaplaincy service at the John Randolph Medical

Center, Hopewell, Virginia.

- 3) All applicants must meet the approval of their individual churches as authorized by their Pastors.
- 4) All applications must be legibly completed and signed by the applicant
- Verification will be made on applicant's statement that he or she is enrolled or attending a college, university, or vocational school prior to awarding of any scholarship.
- The Bolden Bradby Memorial Scholarship will be awarded to an applicant one time only.
- 7) The scholarship will be awarded to students who have completed at least one semester or one quarter of an approved institution of higher learning. The scholarship will be awarded in the month of January. The student must request his or her award by submitting a letter of request to the Scholarship Committee, along with proof of first semester's attendance.
- All applications must be received by May 1<sup>st</sup>. No applications will be accepted after this deadline. It is the responsibility of the student to ensure that his or her application is received by the due day. No exceptions will be made.
- Any changes to the criteria of the scholarship award by the Bolden Bradby Committee must be approved by the Moderator and the Executive Committee. The Moderator must approve all scholarship disbursement funds. Scholarships disbursements are payable only if the church and applicant are both in good standing as set forth by the rules of the Lebanon Virginia Baptist Association

#### FOREWORD

The work of the Lebanon Virginia Baptist Association is contingent upon the smooth and methodical workings of the committee, which has been established. This manual has been prepared to provide each committee with its purpose, method of operation and its responsibilities to the Association.

Each committee is responsible for making an annual report to the Association and some committees may be required to make additional reports during the year to the Executive Council. Deadlines for each report will be established so that the report may be printed in advance of a scheduled meeting or function and then made available at that meeting for our members and delegates. We thank you for your prayerful and cheerful cooperation as we work together.

#### CONDOLENCE COMMITTEE

The Condolence Committee is to make record of and report to the Association the names, addresses and the name of churches of members who die within the reporting period (each of the four meetings of the Association).

1) The committee will function throughout the year.

2) The committee will establish and maintain contact with specific individuals of member churches in the Association.

#### HOSPITALITY COMMITTEE

The Hospitality Committee will work with an ad hoc committee established by the church which hosts a meeting or function of the Association. The responsible include:

1) Making provisions for banquets and other gatherings for the Association (e.g., meals, parking, and directing of guests throughout the facility)

2) Any additional needs or services to be performed by this committee will be requested through the Pastor of the host church.

3) The Association through this committee will extend its formal thanks to the host church at the end of the meeting or function.

#### **NEW BODIES COMMITTEE**

The New Bodies Committee will serve as the instrument through which perspective churches will become familiar with the Lebanon Virginia Baptist Association and Allied Bodies. When perspective churches are presented, the New Bodies Committee will hold dialogue with the candidate congregation to inform them of the atmosphere of fellowship found in the Lebanon Association rules and regulations, expectations, etc. The New Bodies Committee, after the dialogue, will make recommendations pertaining to the perspective congregation at the Annual Session.

The New Bodies Committee will actively solicit the involvement of Baptist Churches which have no affiliation with any Association.

The New Bodies Committee will maintain accurate records of meetings and this report will also be made at the Annual Session.

#### EXECUTIVE COUNCIL

The members of the Executive Council will share equally in the responsibilities of guiding the Lebanon Virginia Baptist Association and Allied Bodies. The Executive Council will exercise the rights and authority to form policy, give directions and set action under the auspices of the Association. The duties of the Executive Council will be:

- 1) To give leadership and direction to the Association
- 2) Preparing and recommending the annual budget
- 3) Developing the annual calendar for the Association
- 4) Outlining the programs for the Association
- 5) Selecting speakers, preachers and presenters for the Association
- 6) Confer meetings to consider the concerns of the Association
- 7) Fulfill all other duties as specified by the Association
- Urge Association churches to canvass the community for issues and concerns and report these concerns back to the Association or direction

#### BUDGET & FINANCE COMMITTEE

The Budget and Finance Committee shall prepare and monitor the budget for the Lebanon Virginia Baptist Association and Allied Bodies and will have the responsibility of attending to the fiscal concerns of the Association.

- 1) This committee shall consist of no more than seven (7) members and no less than three (3) members; one of whom will be the treasurer. Members serving will be appointed by the Executive Council, Terms of service will be staggered (4 years). The Treasurer and the Chairman will not be limited to term.
- 2) The names of three (3) members of the committee will be registered at the banking institution(s). Any two (2) names of the three registered names will make a check valid.
- 3) The committee will receive recommendations and reports from sources (i.e., Moderators, Presidents, Scholarship Committee, Public Relations, individuals, etc.) in preparation of the budget.
- 4) The budget shall be based upon the annual contributions of the member churches at the annual meeting.
- 5) The budget becomes effective January 1, subject to approval by the Association following the annual session.

6) Member churches will be encouraged to make semi-annual, tri-annual or quarterly contributions

7) The fiscal year for the Association shall be from January 1 through

December 31.

8) All requests for funds shall be by voucher, be the request budgeted or not. All vouchers must bear the signature of the Moderator.

- 9) The Committee shall be sure of the balance of the Association. A biannual typewritten report will be submitted to the Executive Council and will include the following information:
  - a) Numerical listing of each check

b) Date of each check

- c) To whom the check was written (purpose and amount) A quarterly report should be made at each session listing the receipts and expenses. A complete annual finance report should be made at the Annual Session.
- 10) The committee shall submit its books for annual audit by January 31 of each year. The results of the audit will be reported at the annual session.

#### PUBLIC RELATIONS

The Public Relations Committee has the responsibility of relaying the occasions, events, items of interest and business of the Association to its officers, member churches and delegates and to the media (newspaper, radio, t.v.) where applicable. The committee is also responsible for compiling, printing, and distribution of the minutes of each session of the Association; training or seminar materials and the Annual Journal. The Executive Secretary of the Association shall chair this Committee. Specific duties and responsibilities shall include:

1) The committee shall review all reports and items which will be entered into the Annual Journal and to conduct all editing procedures necessary

for or printing.

2) The journal shall be prepared and submitted to the Executive Council by April 1 each year. (council should submit Journal for publication by May 1)

3) The Journal shall be ready for distribution to member churches by June 15. Each church will receive 6 copies of the Journal. The Council will indicate time and place for distribution.

4) An annual report shall be made to the Association.

#### REGISTRATION COMMITTEE

The Registration Committee has the responsibility of accurately registering all delegates, representatives and guest on all occasions, functions and events of the Association where registration is applicable. Pre-registration will be encouraged for the session. The registration information will include:

- 1) The occasion and date
- Name of delegate, representative or guest (their name, address [zip code] telephone number [area code])
- 3) Church represented/name of Pastor or organization
  - a) The committee will prepare appropriate badge and other forms of identification for registrants and the packets for the annual session
  - b) The committee will work together with the Public Relations and Hospitality Committees to provide technical or logistical support to member churches who will host functions or events of the Association.
  - c) The committee will make a report on the number of registrations after each session. An annual report shall be made in the July session.

#### HISTORY COMMITTEE

The History committee is responsible for compiling the history of the Association and Allied Bodies from their beginnings through the merger and following. The committee shall maintain good records of the development of the Association and place those records in narrative form annually. Each tenth (10th) year, the history should be presented in booklet form.

#### MUSIC COMMITTEE

The Music Committee is responsible for providing the music for each session.

#### BOLDEN BRADBY SCHOLARSHIP COMMITTEE

The duties of the Bolden Bradby Scholarship Committee shall be as follows: to insure applications are received by the deadline, to review applications to insure that

all documents are completed according to requirements, and to write checks and send them to the financial secretary for second signature, and also to ensure that the churches are in good standing.

#### TIME AND PLACE COMMITTEE

The Time and Place Committee has the responsibility for communicating with Association Churches for the purpose of scheduling hosts for the individual division sessions (Fall, Winter, Spring, and Annual), and other gatherings that the Association may hold.
